

**WWF-CANADA VIRTUAL CLIMB FOR NATURE  
RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AND  
MODEL RELEASE AGREEMENT (THE "AGREEMENT")**

***PLEASE READ THIS AGREEMENT CAREFULLY BEFORE SIGNING.***

TO: WWF-Canada, World Wildlife Fund International, (collectively the "**Organizers**") and their affiliates, individually, and as a whole, together with their officers, directors, employees, servants, agents, affiliates, suppliers, successors and assigns, volunteers, sponsors, donors, and funders (collectively the "**Representatives**")

I wish to participate in the **WWF-Canada Virtual Climb for Nature (the "Event")** on Saturday, April 4th or Sunday, April 5th, 2020, benefiting WWF's conservation efforts. In return for my being permitted to participate (the "**Participant**") in the Event, I hereby agree, as follows:

1. I will abide by all Event rules, regulations, instructions and the directions of Event officials, as well as applicable municipal, provincial and federal laws and regulations.
2. I **VOLUNTARILY ASSUME THE RISKS OF PARTICIPATING IN THE EVENT**. I understand that the risks of participation may include exertion-related health problems; cuts or other injuries due to slips, falls, or collisions with other participants; and other incidents that could cause damage to property, personal injury or death, and related losses. I am solely responsible for my personal health, safety and property while participating in the Event.
3. By signing this Agreement, I **UNCONDITIONALLY RELEASE AND FOREVER DISCHARGE THE ORGANIZERS AND THE REPRESENTATIVES FROM ANY AND ALL CLAIMS, ACTIONS, SUITS, PROCEEDINGS, DEMANDS, DAMAGES AND LIABILITIES WHATSOEVER** (collectively the "Claims") **FOR DEATH, PERSONAL INJURY, DAMAGE OR LOSS TO PROPERTY AND ANY AND ALL OTHER LOSS OR INJURY**, including, without limitation, economic loss or consequential damages (collectively the "Damages") that may result, directly or indirectly, from: my participation in the Event, activities related to and/or activities in preparation for the Event. This Agreement applies regardless of whether the Damages are occasioned, wholly or in part, by any act or omission of the Organizers or the Representatives, whether negligent or otherwise.
4. I will make no demand or claim against any other person who could claim against the Organizers or and the Representatives for the matters this Agreement covers. I **AGREE TO INDEMNIFY AND SAVE HARMLESS THE ORGANIZERS AND THE REPRESENTATIVES FROM CLAIMS FOR ANY AND ALL DAMAGES** suffered by me and/or by any other persons arising from: my participation in the Event, whether the Damages are occasioned, wholly or in part, by any act or omission of the Organizers or the Representatives, whether negligent or otherwise.

**Photo, video, audio, film, interview, climb time results release:** I give WWF-Canada permission to take and publish photographs, videotapes, audiotapes, films and interviews and climb results of me and/or the child or minor participant named below (the "Images") for current and future use in WWF-Canada materials, including marketing and promotional materials, WWF-Canada's official website and social platforms, without compensation to me. I also understand that external media organizations may attend events involving WWF-Canada and hereby give permission for the publication and/or broadcast on-line, on television and/or radio of the Images.

**Donations non-refundable:** I understand that all donations processed by WWF-Canada are non-refundable and non-transferable, even if I do not participate in the Event for any reason.

**Applicable laws and jurisdiction:** This Agreement is governed by the laws of the Province of Ontario and the laws of Canada applicable therein. Should any portion of this Agreement be held to be invalid by any court of competent jurisdiction for any reason, such portion will be severable from the remaining provisions herein and will not otherwise affect the remaining provisions of this Agreement which will continue to be enforceable.

**Submission of Form:** I am the age of majority in my province of residence and have read (or have had read to me) this Agreement. I have been given the opportunity to seek independent legal advice in respect of this Agreement. I fully understand and agree with the terms of this Agreement. If the Participant is under the age of eighteen, I confirm that I am the child or minor participant's parent or guardian, and that I have executed the Agreement on behalf of the Participant. I understand and agree that it shall bind my heirs, assigns, administrators, executors, legal representatives, next-of-kin, and anyone else who may make a claim for me or on my behalf. **I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING THIS AGREEMENT, AND CONFIRM THAT I HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT OR DURESS, OR ASSURANCE OR GUARANTEE BEING MADE TO ME.**
